John Colfelt and his sons, John and Charles, came from Le Locle, Canton de Neuchatel, Switzerland. Cantons were organized in 1803 and modern boundaries were achieved, with some minor adjustments, by 1815 The area has been fought over for centuries and controlled at various times by Prussia and France. The region was under French sovereignty between 1806 and 1814. The region has a populaltion that speaks French, German, and Alsatian, a German dialect. Colfelt's ancestors could have very well been Prussian (German) or French. See The Encyclopedia Americana International Edition, Vol. 26, page 144 (2003) for a brief history of the area.

L.M Colfelt (BK 53914) had a brother Charles A. COLFELT, BK 53921, b. abt. 1846 in PA, a R.R. station agent.
